Talapatra, Judge, High Court of Tripura for online **Workshop on Human-Trafficking in collaboration with the Central and East European Law Initiative (CEELI Institute), Prague and Federal Judicial Center (FJC), Washington DC.,** for Higher and District Judiciary scheduled from **19-22 November, 2021.**

The Workshop will have 7 Sessions of roughly 75 minutes each over the course of the 4 days- 2 on Friday, 2 on Saturday, 2 on Sunday, and 1 on Monday. The Friday Sessions (which include a shorter intro session of a total of 120 min) would start at 6 pm IST, the Saturday and Sunday Sessions at 2 pm. and the Monday Session again at 6 pm. They would be delivered in a mix of live presentations and pre-recorded moderated discussion which would be led by one of the Prague-based faculty.
